Public support is critical to the ability of registered charities to #buildbackbetter. The not-for-profit financial reporting standards were introduced, in part, to maintain strong public support by promoting transparent reporting by registered charities and by providing a framework to help them effectively tell their stories. This year, the Accounting Standards Framework, under which the reporting standards for charities are set, has been subject to review by the External Reporting Board (XRB). Also a postimplementation review of the Tier 3 and Tier 4 reporting standards is expected to begin soon. In this session you will hear from Anthony Heffernan, Director Accounting Standards at the XRB, on the issues considered and the feedback received to date on both these reviews.
